3. Technical information about this website's accessibility

Stradbrokepc.org is committed to providing a website that is accessible to the widest possible audience, regardless of circumstance and ability in accordance with the *Public Sector Bodies (Wesbsites and Mobile Applications) (No. 2) Accessibility Regulations 2018*.

Stradbrokepc.org is based on a Wix template.

Wix issued the following statement:

The website was last audited in August 2023, and the following was noted:

This website is partially compliant with the Web Content Accessibility Guidelines version 2.1 AA standard, due to the non-compliances listed below.

Each page of the website was audited and any errors rectified

Some pdfs and other documents on the site do not meet the accessibility criteria.

5. Continued improvement / how we test the site.

Each page is checked against the government guidance issued in August 2019.

Most page content will continue to be monitored using Wave <u>accessibility checker</u> when updates are undertaken.

The whole website will be checked annually.
